# Workshop Descriptions Fall Conference 2018

## A-1

### **Regenerative Justice**

This presentation will outline a new form of justice, called regenerative justice. Regenerative justice blends restorative with generative justice, which involves helping participants in victim-offender mediation sessions to build new positive life meanings, particularly meanings that have to do with wrongdoing itself and the process of "making things right", in order to enable them to better cope with new life circumstances and pursue a more peaceful life path moving forward. The practice of Logotherapy, coming from the Psychologist Viktor Frankl, informs this analysis and provides practical strategies to facilitate the meaning-building process. We will therefore explore both the theory of regenerative justice, as well as practical guidelines to bring this unique practice to life.

## A-2

### **Parallel Universes: Applying Mediation Skills in Our Communities**

This session highlights how mediators from the Piedmont Dispute Resolution Center (PDRC) helped strengthen the relationship between African American residents and law enforcement in Warrenton, VA by applying the basic skills of active listening, effective questioning, clarifying needs, reaching common ground and providing a safe space for everyone to speak their truth. Workshop participants will be challenged to apply the techniques used by PDRC mediators in their own practice and in their communities.

## B-1

### **The Role of Emotional Intelligence in Mediation**

This course will provide participants with knowledge regarding how emotional intelligence affects individuals' behavior in mediation, both from the clients and mediators' perspective. Participants will take an emotional intelligence self-assessment inventory and discuss ways to improve their own emotional intelligence skills related to the mediation process.

## **Workshop Descriptions Fall Conference 2018**

### **C-1**

#### **WHAT? SO WHAT? NOW WHAT? The Role of Self Reflection in Mediator Professional Development**

In this workshop, we will explore the concept of self-reflection as a component of mediator professional development. The formation of a professional identity as a mediator does not come at the flip of a switch. It is like the never-finished poem or work of art – something you contribute to over a long period of time, knowing that it will never be perfect.

### **C-2**

#### **2018 General Assembly Plays with Child Support:**

Just when you were getting comfortable with the last round of changes to the Virginia Child Support calculations, the 2018 Virginia General Assembly amended the statute to codify methods for calculating several parenting arrangements that were not covered by the statute. Now there is a required method to calculate support where some children have a "shared" schedule while other children of the same parents have a "sole" schedule. And there's now a way to calculate what happens when there is more than one "shared" schedule for more than one child. Learn about the changes and how to do the new calculations. The "Rapid Fire" quiz will help you figure out which of the six possible new worksheets to pick from. And there'll be a demonstration of the updated online free tool (VaSupportCalc) to do the calculations.

### **D-1**

#### **Public Policy Mediation - A Supplement to the Legislative Process**

This session will look at public policy mediation as a supplement to the legislative and regulatory process. Statutory authorization and the applicability of FOIA to such mediations will be discussed. The difference between public policy mediation and mediations arising out of litigation and family matters will be highlighted as well. Examples from past mediation processes will be used to illustrate key concepts.

### **D-2**

#### **2018 General Assembly Plays with Child Support...And You Can Too!:**

Get your math geek on. We'll do calculations both with pencil and paper and then with online and Excel spreadsheet calculators. This hands-on presentation will include a number of complex calculations that you'll do with the help of the panel. By the time we're done, you'll understand the new legislation and tools you can use to do the calculations. We'll look at the new guideline possibilities along with some out-of-the-ordinary and overlooked fact situations that may generate "exceptions" to the standard calculation results. Bring a calculator, pencils (and erasers—just in case!), paper AND a computer or tablet with WiFi capability so you can access the Internet. (A cellphone with Internet access won't be helpful!) Even better, if your computer has Excel, you'll get twice as much from this class.

# Workshop Descriptions Fall Conference 2018

## **Bookzone**

The Bookzone will be a one hour facilitated discussion of **Inside Out** by Gary J. Friedman( American Bar Association, 2014). The focus of the book is *Self Reflection for Conflict Professionals Intensive (SCPI, pronounced skippy)*. SCPI is a program developed by Friedman and Himmelstein, both of whom are experienced lawyers and mediators. They collaborated with a Zen Buddhist teacher, priest, and poet, Norman Fisher.

## **E-1**

### **Peer Mediator Consultation**

In this workshop participants will explore "critical moments" in their mediation cases and reflect on how these critical moment interventions affected the mediation's outcome. The workshop uses facilitated dialogue for the discussion and is based on material from Michael Lang and Alison Taylor 's book, *The Making of a Mediator*.

## **E-2**

### **The Art of Mediating with Couples who Do – or Don't – Negotiate Effectively with Each Other**

It makes a difference in mediating divorce agreements whether the couple can negotiate effectively with each other, or whether their negotiating is seriously or somewhat dysfunctional. This session covers the degree of effective or dysfunctional negotiating that mediators encounter. It also reviews the difference in mediating strategies depending on the different ways in which spouses negotiate.

## **Ethics**

### **Staying Out of Trouble: Seeking Practical Solutions to Sticky Ethical Situations**

Some of the more frequent ethical issues mediators face are those related to self-determination and impartiality. This interactive session will explore some of those issues, and focus both on preventing trouble as well as solving difficulties when they arise -- especially in terms of applying our standards of ethics. We'll focus on realistic and practical scenarios, and we invite you to bring your own for discussion!



## Speaker Biographies

### **Preston Bryant, Senior Vice President, McGuire Woods Consulting**

Preston Bryant is a Senior Vice President McGuire Woods Consulting, where he advises clients on regulatory affairs, infrastructure and economic development, and environmental and energy matters. He served in the Virginia House of Delegates from 1996 to 2006 and in Governor Tim Kaine's cabinet as Secretary of Natural Resources from 2006 to 2010. Mr. Bryant is a certified mediator and often provides public policy mediation services to Virginia state agencies. He is a graduate of Randolph-Macon College, the University of Richmond, and the University of London.

He has peer-reviewed publications that focus on restorative, transitional, and regenerative justice, but also has publications outlining: holistic peace, critical conflict resolution, evidence-based conflict management, conflict transformation, and generalist conflict resolution practice. ## Speaker Biographies

### **Dr. Antionette V. Irving, Sheriff City of Richmond, Mediator**

On January 1, 2018, Dr. Antionette V. Irving became Sheriff of the City of Richmond facilitating one of the largest Sheriff's Offices in the Commonwealth. Sheriff Irving is a proud native of the City of Richmond and product of the public school system. She grew up in the city's Creighton Court public housing complex, where she learned the values of respect and discipline that have served her throughout her career. Sheriff Irving enjoyed a 26+ year career in the Henrico Sheriff's Office and was the first woman to be promoted to the rank of Major in either the Henrico Sheriff's Office or Police Department. Sheriff Irving is a committed mentor, civic leader, and philanthropist in the City of Richmond, volunteering within the community and through the Saint Paul's Baptist Church and the Salvation Army Boys and Girls Club. A strong proponent of education, she strives to encourage young people to develop values, self-esteem, character, and discipline through AVI Foundation, which she founded and where she serves as President. In addition to her BA in Criminal Justice from Shaw University, Sheriff Irving earned her Master of Science in Administration from Central Michigan University, and her PhD in Business Administration with a concentration in Criminal Justice from Northcentral University.

### **Reverend Dr. James R. Kelly**

She is a trainer for General District Court and J&DR Court mediation certification courses, as well as a variety of mediator recertification courses. Ms. McCue is a past Secretary and a former member of the Board of Directors of the Virginia Mediation Network, and a past president of the Central Virginia Mediation Network. Ms. Parker has been involved in mediation and restorative justice for 29 years as a certified mediator, mentor, trainer and program developer. She has worked in schools for 26 years as a trainer and program developer of peer mediation and restorative practices, including in Fauquier and Prince William Counties and Alexandria City Public Schools. She sits on the Supreme Court of Virginia's Dispute Resolution Advisory Council and Mediator Complaint Panel. Her awards include the Supreme Court of Virginia Award for Outstanding Achievement in Community Mediation, Virginia's 50 Influential Women by Virginia Lawyers Media, and the Distinguished Mediator Award from the Virginia Mediation Network. Ms. Parker holds a B.A. from the University of Michigan and an M.B.A. from the University of Mary Washington.

### **Karen Richards, Mediator, Trainer**

Karen H. Richards, of Karen Richards Training & Mediation LLC, has worked as a mediator and conflict resolution and communication trainer since 1993 serving thousands of individuals, families and public and private organizations through training, mediation and facilitation. Ms. Richards is a Virginia Certified general and family mediator, mentor, and trainer, and provides mediation services in southeastern Virginia. She also serves as a Workplace Mediator for the Virginia Department of Human Resource Management Office of Employment Dispute Resolution's statewide workplace mediation program. Ms. Richards is certified to administer and deliver the Myers-Briggs Type Indicator (MBTI®), Steps 1® and 2® and enjoys working with individuals and organizations using the MBTI®.

Ms. Richards is the Immediate Past President of the Virginia Mediation Network and has served on the Board of Directors of the organization since 2012.

### **Mark Rubin, Executive Director, Virginia Center for Consensus Building, VCU**

Mark Rubin is a certified mediation, lawyer, former lobbyist at the Virginia General Assembly, and former state government official. Jeannette regularly teaches courses and workshops about collaboration and problem-solving processes. She taught negotiation and mediation at American University's Washington College of Law for ten years (2005-2015) and has been a conflict resolution trainer for Northern Virginia Mediation Service since 1994.
